

# Ostathna Terms of Service

This Agreement contains all of the terms and conditions between Ostathna Inc. ("Ostathna") and you ("User") and governs the use of the service offered at the Ostathna Website and through any Ostathna mobile application (collectively, the "Site"). Please read this Agreement before using the Site. Use of the Site constitutes an agreement with the Terms of Use (this "Agreement"), whether or not you are registered as a member of Ostathna ("Member"). If you wish to become a Member and make use of Ostathna (the "Service"), then please read this Agreement. By using this Site, all users do hereby represent, warrant, understand, agree to and accept all terms and conditions contained herein. If you object to anything in this Agreement or the Ostathna Privacy Policy, do not use the Site or the Service. The Terms of Use are subject to change by Ostathna at any time, effective upon posting on the Ostathna Website, and your use of the Site or the Service after such posting will constitute acceptance by you of such changes.

## 1. Acceptance of Terms of Use Agreement

This Agreement is an electronic contract that sets out the legally binding terms of your use of the Site and the Service. This Agreement may be modified by Ostathna from time to time, such modifications to be effective upon posting by Ostathna on the Site. This Agreement includes the Ostathna Privacy Policy. By accessing the Site or becoming a Member, you accept this Agreement and agree to the terms, conditions and notices contained or referenced herein. In addition, by accessing the Site or becoming a Member, you consent to have this Agreement provided to you in electronic form.

## 2. Terminology

For the purpose of this agreement, the word "must" and "will" constitute a requirement, while the words "should" and "could" constitute a suggestion but not a requirement.

## 3. Ostathna is a Service

The Site is a platform for enabling the connection between individuals ("Users") and/or institutions ("Institutions") and Ostathna. Ostathna provides access to an educator for Users who may or may not be registered on behalf of an Institution. Ostathna will make every effort to ensure that an educator is online at all times of day, unless otherwise

noted in writing on the Site. In the event an educator is not available in a particular field where a User seeks support, Ostathna should inform the student when the next available Educator will be accessible. Users do hereby represent, understand and expressly agree that Ostathna will make every effort to control the quality, timing, legality or any other aspect whatsoever of the services actually delivered by its Educators. Institutions will be responsible for of the integrity, responsibility or any of the actions whatsoever of the Users. Ostathna makes no representations about the suitability, reliability, timeliness, and accuracy of the services provided by Educators. Ostathna, resellers, distributors, and licensees does not assume any responsibility for the accuracy or reliability of any information provided by Educators on this Site. Ostathna does not assume and expressly disclaims any liability that may result from the use of this information. Ostathna is not responsible for the conduct, whether online or offline, of any user of the Site or Member of the Service. All users including both Institutions and Educators do hereby expressly agree not to hold Ostathna (or Ostathna's officers, directors, investors, subsidiaries, agents, assignees, representatives, advertisers, marketing partners, licensors, independent contractors, recruiters, corporate partners, resellers, licensees, distributors, or employees, hereinafter "Affiliates") liable for any instruction, advice or services delivered which originated through the Site and Ostathna and its Affiliates expressly disclaims any liability whatsoever for any damage, suits, claims, and/or controversies that have arisen or may arise, whether known or unknown therefrom.

By requesting to use, registering to use and/or using the Site, Institutions, Users and Educators represent and warrant that you have the right, authority and capacity to enter into this Agreement and you commit to abide by all of the terms and conditions hereof. In addition, you represent and warrant that you and each member of your household (a) have never been the subject of a complaint, restraining order or any other legal action involving, arrested for, charged with, or convicted of any felony, any criminal offense involving violence, abuse, neglect, fraud or larceny, or any offense that involves endangering the safety of others, and (b) have not been and are not currently required to register as a sex offender with any government entity. You hereby authorize Ostathna to verify your representations and warranties herein, and you acknowledge that Ostathna reserves the right, but not the obligation, to verify such representations and warranties, which may include, without limitation, conducting criminal background checks and using other

available public records, and to take action it deems appropriate in its sole discretion, including but not limited to terminating your membership, should it determine, in its sole opinion, that you have violated any representation or warranty or any other provision of these Terms of Use. By using this Site, you do hereby represent, understand, and expressly agree to hold Ostathna harmless for any claim or controversy that may arise from any disputes between you and any other user(s) of the Site. Ostathna will use its reasonable efforts to monitor profiles, actions, comments, and general usage of the Site and suspend privileges to any User or Educator not adhering to the policies of the Site and will not issue refund for services paid in the event that usage privileges are revoked.
